# **DANCE GUEST PASS**

The guest MUST enter and leave the dance with the Wilson Creek High student.

Any disruption of any WC activity, including dances, such as fighting or criminal offenses can result in the arrest of the guest. Any guest who violates any school rules will be barred from attending any future WC dances or activities. As well, the WC host student will not be permitted to invite another guest to any school dance or activity for the remainder of the school year. Former students who have had significant discipline or attendance issues while attending Wilson Creek School District may be excluded from the dance/activity.
