Job Opening: Wilson Creek School District is seeking a Boys Junior High Assistant Baseball Coach. Our baseball teammates join with Odessa School District and all practices and home games take place at Odessa School.

Supervisor(s): Head Junior High Coach and Athletic Director

Primary Function: Position is responsible for assisting the head coach in coaching student athletes in the game strategies and techniques to prepare for athletic competition. The position is responsible for conducting practices in a motivating way so that the student athletes develop an appreciation of the sport.

Requirements: Candidate must hold a valid first aid/CPR Certificate or enrolled in a course at the time of employment. Must have a clear WSP background check (school district will facilitate background check). Continuing coach's education hours are required throughout the duration of employment.
